Snowshoe 50th Anniversary Golden Giveaway
Official Rules**

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES. A PURCHASE OR PAYMENT WILL NOT INCREASE OR IMPROVE YOUR CHANCES OF WINNING.

1. SPONSOR. The “Snowshoe 50th Anniversary Golden Giveaway” (the “**Sweepstakes**”) is sponsored by Snowshoe Mountain, Inc. (“**Sponsor**”) and the address at which Sponsor may be contacted is 10 Snowshoe Drive, Snowshoe, WV 26209.

2. ELIGIBILITY. The Sweepstakes is only open to entrants who, as of the date of entry, are: legal residents of the fifty (50) United States or the District of Columbia who are at least eighteen (18) years of age or older. Entrants must also have internet access in order to enter. This Sweepstakes is void outside the fifty (50) United States and the District of Columbia and where prohibited or restricted by law. Employees of Sponsor and Alterra Mountain Company, and each of their respective affiliates, sponsors, advertising and promotion agencies and members of the immediate family (parent, child, sibling and spouses) and of the household in which all such persons are domiciled are not eligible to enter. The Sweepstakes is subject to all applicable federal, state and local laws and regulations.

3. TIMING. The entry period for the Sweepstakes shall take place as follows: November 4, 2024 from 9:00am Eastern Time (“**ET**”) through 11:59 p.m. ET on December 23, 2024 (the “**Entry Period**”). **Entries received other than during the Entry Period, and duplicate entries, will be determined ineligible and will be discarded.** Sponsor’s computer is the official timekeeping device for the Sweepstakes.

4. HOW TO ENTER. There are two (2) ways to enter the Sweepstakes, both of which are online. **ELIGIBLE ENTRANTS MUST ENTER IN ACCORDANCE WITH THESE OFFICIAL RULES. NO OTHER METHOD OF ENTRY WILL BE ACCEPTED.**

a. TO ENTER VIA SWEEPSTAKES INVITATION: If you receive an email from Sponsor inviting you to participate in the Sweepstakes (the “**Sweepstakes Invitation**”) during the Entry Period, you will be automatically entered in the Sweepstakes, provided that you must confirm your email address on the Sweepstakes registration page The Sweepstakes Invitation is emailed to certain guests who have entered into certain transactions with Sponsor during a period prior to the end of the Entry Period.

b. TO ENTER AT SPONSOR’S WEBSITE: During the Entry Period, visit Sponsor’s Sweepstakes webpage located at www.snowshoemtn.com/sweepstakes and complete the online entry form and submit it in accordance with the on-screen instructions.

c. FOR ALL ENTRIES: There is a limit of one (1) entry per person and per email address during the Entry Period. All entries must be received during the Entry Period. Any person found entering the Sweepstakes using more than one e-mail address will be disqualified. Any entries attempted through the use of agencies or robotic, repetitive, automatic, programmed or similar methods will be void. Wireless carrier's data rates may apply if an entrant enters the Sweepstakes using a mobile device. In the event of a dispute as to the identity of any entrant, the authorized account holder of the e-mail address associated with the entry will be deemed to be the entrant. The "**authorized account holder**" is the natural person assigned an e-mail address by an internet access provider, online service provider or other organization responsible for assigning e-mail addresses for the domain associated with the submitted address. Potential winner may be required to show proof of being the authorized account holder. All entries become the exclusive property of Sponsor and none will be acknowledged or returned. Proof of submission will not be deemed to be proof of receipt of entry by Sponsor. All entrants and entries are subject to verification prior to the awarding of a prize, as are the eligibility, agent and other claims of/information provided by a potential prize winner. Entrants will cooperate with Sponsor and its representatives in connection with any and all verification activities. All entries that are incomplete, illegible, damaged, irregular, have been submitted through illicit means, or do not conform to or satisfy any condition of the Official Rules (defined below) may be disqualified by Sponsor. Sponsor takes no responsibility for lost, stolen, delayed, damaged, misdirected, late or destroyed entries, or for typographical or other production errors. Sponsor is not responsible for any errors or omissions in printing or advertising the Sweepstakes.

5. AGREEMENT TO OFFICIAL RULES AND DECISIONS. The Sweepstakes will be run in accordance with these Official Rules, subject to amendment by Sponsor (the "**Official Rules**"). Entrants must comply with the Official Rules and will be deemed to have received and understood the Official Rules by participating in the Sweepstakes. The terms of the Sweepstakes, as set out in the Official Rules, are not subject to amendment or counter-offer, except as set out herein. Sponsor's decisions with respect to the Sweepstakes (including, without limitation, decisions regarding eligibility of entries, the selection of entrants and winner, and awarding of the Prize) are final and binding. If any provisions of the Official Rules are held to be invalid or unenforceable, all remaining provisions hereof will remain in full force and effect.

6. PRIZE DRAWING; ODDS; AWARDING OF PRIZE; PRIZE REDEMPTION. On or around December 23, 2024, Sponsor will randomly select one (1) entrant from all qualified entries received by Sponsor during the Entry Period. The odds of winning the Prize depend on the number of eligible entries received. The potential winner selected must comply with all terms and conditions of these Official Rules and winning is contingent upon fulfilling all requirements set forth herein. The potential winner will be notified by email and/or phone. The potential winner will be required to execute and return to Sponsor a Declaration of Eligibility, a Release of Liability, and, except where prohibited by law, a Publicity Release (a "**Declaration and Release**") in the form(s) provided by Sponsor in order to claim his/her prize. The Declaration and Release must be returned to Sponsor by the date and/or time indicated within the Declaration and Release. If a potential winner cannot be contacted within seventy-two (72) hours of the first attempt to contact him/her, or if a potential winner fails to return the Declaration and Release within the specified time, or if any prize or prize notification is returned as undeliverable, or if a potential winner is found to be ineligible by Sponsor in its sole discretion, or if a potential winner does not comply with the Official Rules, then the potential winner may be

disqualified and an alternate potential winner selected by Sponsor in his/her place at random from among all eligible non-winning entries received by Sponsor for the Sweepstakes. In such event, an alternate potential prize winner will be notified as described above and will be required to return the required documents to Sponsor as described above; provided, however, Sponsor may alter the above timing to meet its Sweepstakes schedule.

- 7. PRIZE.** Subject to the terms and conditions of these Official Rules, one (1) grand prize will be awarded in this Sweepstakes. The prize consists of and is limited to a trip for winner and one (1) guest to Snowshoe Mountain Resort, including two (2) nights' stay in lodging (restrictions apply; blackout dates as determined by Sponsor in its sole discretion), 2-day lift tickets for 2, and 2-day ski/snowboard rentals for 2. The ARV of the Prize is USD \$1,500. If the actual retail value is greater than the ARV stated in these Official Rules, the difference will not be awarded in cash or credit. If applicable, winner and guest must travel on the same itinerary and on dates and at times specified by Sponsor. The Prize must be used by March 23, 2025. Blackout dates are defined as Dec. 26, 2024 - Jan. 4, 2025, Jan. 18 - 20, 2025, and Feb. 15 - 17, 2025. Winner must contact Katelynn Chambers at kdchambers@snowshoemountain.com to redeem the Prize.

The Prize is subject to the following additional requirements and restrictions:

Actual ARV depends on lodging rates and, if applicable, currency exchange rates, at the time of booking; if actual ARV is less than the stated ARV in these Official Rules, the difference will not be awarded in cash or other consideration. Any attempt to deliberately damage any website or to undermine the legitimate operation of this promotion is a violation of criminal and civil laws, and should such an attempt be made, Sponsor and Alterra Mountain Company reserve the right to seek remedies and damages to the fullest extent permitted by law, including criminal prosecution. Alterra Mountain Company and Sponsor reserve the right to forbid the framing of any of the contents of this site and, in their sole discretion, to disqualify any individual who tampers with the entry process.

11. DISPUTES.
